<p>General</p>	<ol style="list-style-type: none"> 1. If the Promoter requires any further information in order to validate a submitted Online Claim Form, or if the Eligible Claimant who has provided any invalid tax invoice, and/or photo of the finished Participating Product and/ or if the name/address doesn't match the invoice, the Promoter will inform the Eligible Claimant by email. The Eligible Claimant will then have fourteen (14) days from the date of the notification email to provide the requested information to the Promoter, unless expressly stated otherwise in the notification email. The Promoter may, in its absolute discretion, invalidate any claims if the claimant fails to provide the further requested information within fourteen (14) days of the notification email by the Promoter. 2. The Promotional Period and/or the Application Period may be extended in the Promoter's absolute discretion. 3.
